# 4.1. University Ombud – Dr. Luc Guglielmi

- **4.1.1.** Presented the role of the Ombuds office as independent, neutral, informal, and confidential.
- **4.1.2.** Services are available to students, staff, faculty, alumni, and affiliates of KSU.
- **4.1.3.** Emphasized support in navigating conflicts, harassment issues, workload fairness, and classroom concerns.
- **4.1.4.** Clarified limitations: Ombuds do not advocate, fix problems, or conduct formal investigations. They support faculty in self-advocacy and mediation.
- **4.1.5.** Shared contact information and availability, including after-hours and weekends.
- **4.1.6.** Questions addressed confidentiality, workload fairness, and reporting processes.

#### 4.2. KSU Library - Dr. Chelsea Dickson

- **4.2.1.** Presented on services to empower faculty voices in publishing and research.
- **4.2.2.** Highlighted support for open access publishing, copyright guidance, data services, and the institutional repository.
- **4.2.3.** Shared opportunities include the Open Access Publishing Fund (\$2,000 per project), Affordable Learning initiatives, and repository services for faculty and student work.
- **4.2.4.** Encouraged faculty to adopt OERs to reduce student costs and to publish in open-access platforms.
- **4.2.5.** Slides and resources to be shared with the council.

**4.3.1.4.** Members raised concerns about **parking fees and availability**. Ongoing advocacy for discounted rates was discussed.

# 5. President Update – Christopher Thompson

- **5.1.** Reported outcomes from Faculty Senate:
  - **5.1.1. Revised Al Policy** passed—concerns raised about additional training hours for part-time faculty and potential waivers for practitioners with prior training.
  - **5.1.2. Accessibility training** updates linked to ADA compliance. Discussion of compensation for required training.
  - **5.1.3. Driver Qualification Training**: mandatory but with opt-out options.
  - **5.1.4. Simple Syllabus and CV requirements**: proposal to include limited information for part-time faculty, with drafts forthcoming. Implementation expected Spring 2026.

# 6. Policy & Strategic Planning Update - Russell Spears

- **6.1.** Emphasized PTFC reps' responsibility to communicate updates back to departments.
- **6.2.** Encouraged requesting time on department meeting agendas.
- **6.3.** Discussed opportunities for PTFC committees and future ad hoc groups to respond to policies.
- **6.4.** Stressed the importance of building visibility for part-time faculty contributions.

### 7. Open Discussion / Announcements

- **7.1. Parking**: Ongoing challenges discussed; faculty highlighted inequities compared to students who can avoid passes with minimal penalties.
- **7.2. Terminology**: Some departments are adopting "VITAL faculty" language as asset-based terminology.
- **7.3. External Engagement**: PTFC is exploring connections with other Georgia institutions (UGA, GSU) regarding part-time faculty councils.
